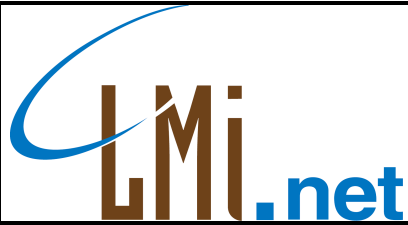

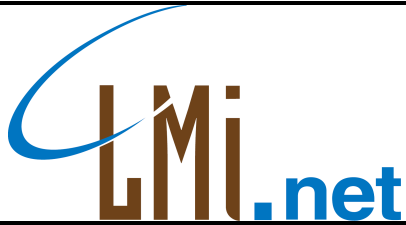

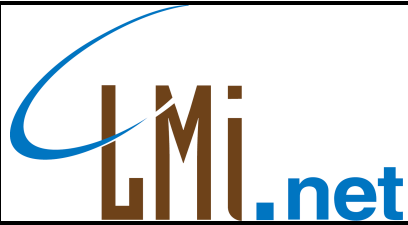

ADDITIONAL FEES

You must read each section and agree that it is your responsibility for paying any applicable fees and taxes.

Early Disconnection Cancellation Fee: There is no term commitment for PHLO, unless you accept a free modem and/or free installation. If you accept the free modem and free installation, and you cancel your service before the two (2) year term is up, you will be charged a \$149.95 cancellation fee. If you accept the free installation, and you cancel your service before the two year term is up, you will be charged a \$100 cancellation fee.

Move Fee: If you need to move your service to a new location, even if the phone number is not changing, you will need to notify LMI.net in writing. You will be charged a \$100 PHLO Move Fee.

Missed Appointment Fee: A \$100 fee will be charged if you are not present at the installation location for a scheduled installation or trouble ticket dispatch appointment, or if the field technician is unable to access the telephone box (NID) or phone closet in order to complete an installation.

Field Technician Trouble Isolation Fee: If a field technician is dispatched to the installation location after the installation of the circuit, and the problem with the PHLO service is neither within the sphere of control of LMI.net (i.e. if the problem is with the inside wiring at your location), you will be charged a \$120 Trouble Isolation fee. In addition to this fee, you will be charged \$60 for each whole or partial 30 minute increment of technician work beyond the first 30 minutes.

THE FINE PRINT

By signing this service agreement you agree that you understand the following:

- A successful installation is defined as (A) when LMI.net can verify that your circuit is passing traffic, OR (B) [i] LMI.net has provisioned network elements under its control, [ii] LMI.net has confirmed the setup of your ADSL2 circuit with your local phone company, and [iii] at least five (5) calendar days have elapsed since the shipment of the Installation Kit. At either of these points (whichever comes first) billing will commence. It does not matter if: you have not used the PHLO line, your computer is not set up yet, you have additional inside wiring to complete, you will still be billed.
- LMI.net PHLO services are considered "commercially reasonable effort" and "rate adaptive" services, meaning that there are no guaranteed minimum or maximum circuit speeds.
- If you wish to cancel your PHLO circuit at any time, you **MUST CANCEL IN WRITING. LMI.net does not take cancellations over the phone.** A written cancellation is defined as either a request mailed to LMI.net's office, a request faxed to LMI.net, or a request e-mailed to "service@lmi.net" from the "Contact E-mail Address" on page one (1) of this agreement.
- Initial Installation of PHLO may involve scheduling a site visit by AT&T in the event that the MPOE is not accessible. LMI.net is not responsible for the punctuality of AT&T technician.
